Short Title</b></p> <p>This Proclamation may be cited as the “Revised Family Code (Amendment) Proclamation No. 1070/2018”.</p> <p><b>2. Amendment</b></p> <p>The Revised Family Code Proclamation No. 213/2000 is hereby amended as follows:</p> <p>1/ Article 193 of the Proclamation is repealed;</p> <p>2/ Paragraph (d) of sub-article (3) of Article 194 of the Proclamation is deleted and the existing paragraph (e) is rearranged as paragraph (d);</p> <p>3/Sub-article (4) of Article 194 of the Proclamation is deleted.</p>

1/ Notwithstanding Article(2) of this Proclamation, pending cases in court related to adoption by a foreigner prior to the coming in to force of this Proclamation shall be settled in accordance with the provisions of the former Proclamation.

2/ This Proclamation shall enter into force on the date of its publication in the Federal Negarit Gazette.
